Re: The Scoop on Marin County Sewer Systems, Part I, June 16, 2014

We are writing to you as members of the Implementation Review Committee of the Marin Chapter of the California Civil Grand Jurors' Association. Our Association's goals are to support the civil grand jury system and promote local government accountability. Our Chapter is composed of former Marin County Civil Grand Jurors. One of the tasks of the Implementation Review Committee is to follow-up on responses to prior Grand Jury recommendations to ascertain the status of their implementation.

Specifically, we are following up on recommendation responses presented in your August 27, 2014 letter concerning the Marin County Civil Grand Jury's June 16, 2014 report, titled "**The Scoop on Marin County Sewer Systems, Part I**". As six months has now passed since the report was published, we would like to know the status of the action detailed in your response to Recommendation R4 as stated below.

**Recommendation R4:** All agencies conduct an analysis to determine the feasibility of using treated wastewater for flushing pipes in routine maintenance work.

**Response:** *SASM has recently partnered with MMWD, Carollo Engineers and the State water Resource control board to produce a Recycled Water Feasibility Study. The use of treated water for flushing pipes was included in the study.*

Dear Ms. Marsh,

This letter is in response to your inquiry dated December 17, 2014. You requested information on the status of the action detailed in our response to Recommendation R4 of "The Scoop on Marin County Sewer Systems, Part I".

The SASM/MMWD Recycled Water Feasibility Study (Carollo, October 2014) recommended a project that includes a truck filling station that could be used by local cities/agencies to flush sewers with recycled water instead of using potable water. The Feasibility Study was accepted and approved by the SASM Board on November 20, 2014. Also at that Board meeting, SASM staff was given approval to move forward in beginning discussions with MMWD on project implementation, including cost sharing and timing for implementation. We expect these discussions to take approximately 6-12 months.

Hi Helene,

You asked some very good questions. I do believe, that there is always an opportunity for all agencies in the County to work together. In fact, we have a group meeting every month where the managers of county's sanitary agencies that have treatment plants exchange information and collaborate. We are aware of the efforts that CMSA is making towards advancing their reclaimed water projects.

I believe that I need to clarify that SASM already reclaims about 7M gallon of water per year for irrigation for many years now. This 7M gallons a year and it is not enough to satisfy the demand. At this point, adding the fill station will not increase the production capacity. I'll also add that the City of Mill Valley is evaluating this option anyway to make sure that the citizens' needs are addressed during this difficult drought period.

To evaluate a potential to increase the wastewater reclamation SASM and MMWD co-sponsored the Reclaimed Water Feasibility Study that we reported about to the Grand Jury last year. This project will require a funding mechanism that is currently under evaluation by MMWD.

In summary:

- SASM already reclaims a portion of its effluent;
- The 2014 RW Feasibility Study identified a potential for additional project to replace the existing reclamation facilities with a larger one at the cost estimated at about \$3M;
- MMWD is evaluating its CIP plans for a possibility of incorporating this project, but it is not a high priority at this point due to the cost/benefit considerations;
- City of Mill Valley owns the reclamation facilities at SASM's plant and is evaluating an option of diverting part of the reclaimed water effluent for the fill station;
- Construction of the fill station will require engineering report and a different permit with MMWD but it will not increase the volume of the reclaimed water currently produced;
