Recommendations and Responses

“The Scoop on Marin County Sewer Systems, Part II”, June 16, 2014 (partial list only)

Recommendation R8: *Alto, San Rafael, Sanitary District #2 and SASM develop and operate an internet website. The website should include, at a minimum, details of the agency and its leadership, board meeting agendas and minutes, an annual budget, audited financial statements, and the SSMP including the OER.*

Response: Currently Being Implemented: the District is a subsidiary district of the Town of Corte Madera and out of concerns of efficiency has maintained numerous District documents on an ongoing basis on the Town's website, including agendas, minutes; annual budget, annual audited financial statements, sewer charges and fees, standard specifications and drawings, sewer code, and permits. The District will enhance the website to better distinguish District documents from the Town's documents within a timeframe that shall not exceed six months from the date of publication of the grand jury report.

Recommendation 9: *The board members at Almonte, Sanitation District #2, San Rafael and Sausalito update their ethics training to be in compliance with state law.*

Response: Currently Being Implemented: the District board members are currently updating their ethics training and anticipate completion of such training within six months from the date of publication of the grand jury report.

Dear Ms. Marsh:

Pursuant to Penal Code Sections 933 et seq., the Board of Directors of Sanitary District No. 2 of Marin County furnished its response to the Grand Jury Report: "The Scoop on Marin County Sewer Systems, Part II" on September 2, 2014. In response to your letter dated January 6, 2015, in which you request an update on follow-up actions taken by Sanitary District No. 2, the District's responses are listed below.

Recommendation R8: That the District develop and operate an internet website. The website should include, at a minimum, details of the agency and its leadership, board meeting agendas and minutes, an annual budget, audited financial statements, and the SSMP including the OER.

Implementation Action Taken: On December 5, 2014, the Town of Corte Madera's new website went live. All pertinent information regarding Sanitary District No. 2 can be accessed via the following link: <http://townofcortemadera.org/391/Sanitary-District-No-2>. Further, a visitor to the site can easily navigate to the District's page via the drop-down menu under the Government tab on the Town's home page. Recommendation 6: The Board members shall update their ethics training to be in compliance with state law.

Implementation Action Taken: This action has not yet been completed. A two-hour, onsite AB 1234 Ethics training session has been scheduled for Thursday, March 5, 2015, through the League of California Cities Institute for Local Government. All members of the Corte Madera Town Council/Sanitary District No. 2 Board, as well as other Town commission members and staff as required by law will be in attendance at this training session. Should anyone be unable to attend at the scheduled time, they will be required to complete the training online on or before March 5, 2015, and instructed to forward their certificate of completion to the District Clerk. Following completion of the AB 1234 Ethics training, the District Clerk will forward a complete set of the certificates of completion for the Sanitary District No. 2 Board of Directors to you via email.

Report a Sewer Emergency

If you notice any the following issues in your neighborhood, please report it by calling Sanitary District No. 2 or Central Marin Police dispatch (415-927-5150) as soon as possible:

- Overflow of sewage from a manhole cover
- Overflow of sewage from a pump station location
- Sewage smell coming from a creek or other waterbody

Do I need a permit?

Sanitary District No. 2 issues permits for all work on the public portion of the sewer collection system. Work requiring a permit includes:

- Repair of an existing sewer lateral
- Installation of a new sewer lateral
- New connection to a sewer main
- Installation of a grease trap/interceptor
- Certain residential/commercial remodels that impact the sewer lateral

How do I get a permit?

Obtaining a sanitary sewer permit involves the following steps:

- Prepare a plan and/or description of the proposed work and review the permit [checklist](#)
- Complete a permit [application](#)
- Submit the application to the District for review
- Pick up the approved permit and pay any applicable fees

Town Council meetings are held on the 1st and 3rd Tuesday of each month, unless otherwise noted. Town Council agendas can be viewed in the [Agenda Center](#), and you may contact the Town Clerk at 415-927-5050 with any questions you may have regarding the agendas.

When a Sanitary District item appears on an agenda, the Council will hear Town items first, the Town Council will vote to adjourn the Town Council meeting and convene as the Sanitary District No. 2 Board of Directors. The Board will then hear the items related to Sanitary District No. 2 and take any necessary actions. Once the Sanitary District items are heard, the Board will vote to adjourn the Sanitary District No. 2 Board meeting and reconvene the Town Council meeting.
